# Q & A: When will 141st St. and Cascade Dr. SE road surfaces be repaired?

Joanne Barnes, Pavement Manager for Snohomish County, contacted the board on August 1st to inform us that testing will begin soon to determine the cause of all of the settling under these roads in our development that result in an uneven surface. They will also be working in tandem with Silver Lake Water & Sewer District to come up with a solution to this problem.

Once the best course of action is determined, the roads will be repaired. Snohomish County plans to begin repaving 141st and Cascade Dr. SE next summer (2015). The project date is yet to be determined, but all homeowners can expect road work to begin sometime between mid-May and September. The exact date for this project will be determined by the contractor's schedule. As more definitive dates are determined by the county manager, we will update the community.

## What can we expect will be done to these roads?

Ms. Barnes stated that there will be milling, plaining, and even possible complete removal of pavement in these areas once the project begins. Ultimately there will be a newly paved smooth surface over all of these areas.
